The Honourable Helen Bowskill was sworn in as Chief Justice of Queensland on 22 March 2022, having served as a Judge of the Supreme Court of Queensland from 10 July 2017, and as the Senior Judge Administrator of the Supreme Court of Queensland from 24 August 2021. Her Honour previously served as a Judge of the District Court of Queensland from 10 November 2014, in that capacity also sitting as a Judge of the Children's Court of Queensland and the Planning and Environment Court.

Her Honour has been a member of the Judicial Council on Cultural Diversity since 2016.



Songwoman Maroochy Barambah

Welcome to Country

Maroochy Barambah is an Aboriginal Elder from Brisbane, Australia. She is of Turrbal and Gubbi Gubbi ancestry with additional bloodline connections to Wakka Wakka, Kamilaroi and Birri Gubba Country. She is the Songwoman and Law-woman of the Turrbal Tribe.

Maroochy attended the Melba Conservatorium of Music in Melbourne and the Victorian College of the Arts where she graduated in Dramatic Arts. Maroochy has had extensive involvement in the Aboriginal community over the last 5 decades. Maroochy has received many awards, both in Australia and overseas.



The Honourable Chief Justice Susan Kiefel AC

HIGH COURT OF AUSTRALIA

AWL Patron's Keynote Address: Yesterday, Today and Tomorrow - A Trend Towards Equity?

The Honourable Susan Mary Kiefel was appointed Chief Justice of the High Court of Australia on 30 January 2017, having served as a Justice of the High Court since 3 September 2007.

Having been admitted to the Queensland Bar in 1975, in 1987 her Honour became the first woman in Queensland to be appointed Queen's Counsel. She became a Justice of the Supreme Court of Queensland in 1993, and a Justice of the Federal Court in 1994. For four years (2003 to 2007) her Honour served as a part time Commissioner of the Australian Law Reform Commission. She also held a commission as a Justice of the Supreme Court of Norfolk Island from 2004. Her Honour was awarded the Companion in the General Division of the Order of Australia in 2011.



The Honourable Former Chief Justice Diana Bryant AO QC

Patron Presentation

The Honourable Diana Bryant AO QC is a former Chief Justice of the Family Court of Australia and was the inaugural Chief Federal Magistrate of Australia, the head of the Federal Magistrates' Court.

Ms Bryant received a Centenary Medal in 2001 and was appointed an Officer in the Order of Australia in 2012 for services to the judiciary and to the advancement of women in the law and was Patron of Australian Women Lawyers until her retirement as Chief Justice.



Professor Gabrielle Appleby

Addressing Sexual Harassment in Australian Courts and Parliaments

Professor Appleby researches and teaches in public law, focussing on the accountability of public power, as exercised by the government, the parliament and the judiciary. Gabrielle is a strong advocate for reform in these areas. Gabrielle is the Director of The Judiciary Project and the Gender and Public Law Project at the Gilbert + Tobin Centre of Public Law, the constitutional consultant to the Clerk of the Australian House of Representatives, and a member of the Indigenous Law Centre.

Sadia Azizi is a lawyer with the Refugee and Immigration Legal Service (RAILS), who is passionate about access to justice and working with vulnerable clients. Sadia came to Australia from Afghanistan at 13 years of age, with no English, and she and her family were subsequently granted protection visas by the Australian government. She gained English proficiency and excelled in legal studies. She worked as a paralegal and then a lawyer with the Australian Government Solicitor. In January 2022, Sadia joined RAILS as a Solicitor in the Afghan Response Team. Sadia will tell her personal story and the work she now does to improve access to justice for refugees and migrants at RAILS.

She is the Co-Chair of the Uluru Dialogue and a Sydney Peace Prize Laureate for 2021 for her work on the Uluru Statement from the Heart.
